- Designation of Current Mailing and E-Mail Address- <u>Form 12.915</u>
- Cover Sheet for Family Court Cases <u>Form 12.928</u>
- Notice of Related Cases Form 12.900(h)
- **Consent for Change of Name (Minor Child(ren))** <u>Form 12.982(d)</u> If only one parent is the petitioner, this form is required of the other parent.
- Background Check for <u>All</u> Adult Petitioner(s) from Court Approved Location (Clerk has list of providers)
 Background check shall include ALL prior, present, future names, and aliases Petitioner was/is/may be known by
- Certified Copy of Minor Child(ren)'s Birth Certificate(s)

SERVICE OF PROCESS IS <u>REQUIRED</u> ON THE RESPONDING PARTY/OTHER PARENT UNLESS CONSENT FOR CHANGE OF NAME (MINOR CHILD(REN)) - <u>FORM 12.982(d)</u> IS SIGNED BY THE RESPONDING PARTY/OTHER PARENT.

Constructive Service

- **<u>MUST</u> attempt Personal Service at respondent's last known address <u>BEFORE</u> proceeding with this type of service** This is a complicated area of the law and you may want to consult with an attorney before using constructive service.
 - Affidavit of Diligent Search and Inquiry <u>Form 12.913(b)</u> Attach supporting documentation.
 - Notice of Action Form 12.913(a)(2) Read instructions thoroughly.
