



What is Juvenile Reentry Treatment Court?

Juvenile Reentry Treatment Court is for those youth offenders that are released from a commitment/residential programs. The program prepares youth for progressively increased responsibility through clear expectations, positive reinforcements, immediate accountability, and consequences for misconduct.

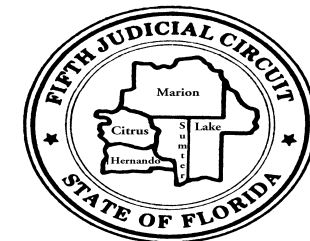
The program also develops new resources and support as needed in the areas of work, education, training, and/or other services. The youth participants are monitored and tested on their ability to interact productively in the community. The program takes approximately 3-5 months to complete. There are no participation fees associated with this program.

Phase One:

4 weeks

Community Transition Phase

The Community Transition Phase begins the day of the juvenile's return to the community. The following objectives are to be accomplished during this phase:

- Provision of services to juvenile and family to help them prepare for
- reintegration into the community.
- Monitor the juvenile's participation in the program.
- Report progress of participant to DJJ Probation Officer.

Participant Requirements:*

- Attend monthly court appearances.
- Comply with random drug screens.
- Weekly case management sessions.
- Start writing in your daily journal.
- Enroll in school and attend daily
- Comply with DJJ Probation.
- Enroll in counseling services.

*Other requirements may be added depending on the needs of the individual.

Phase Two:

4 weeks

Continuing Care Phase

The Continuing Care Phase begins once a juvenile successfully completes Phase One and will continue as long as the juvenile is under Post Commitment Probation (PCP). The following objectives are to be accomplished during this phase:

- Ensure the juvenile's successful adjustment and reintegration into the community.
- Continue to monitor the juvenile's
- participation in the program.
- Ensure the juvenile is attending school and has good attendance.

Participant Requirements (if applicable):*

- Attend monthly court appearances
- Comply with random drug screens
- Weekly case management sessions
- Start a journal through the Reentry Program
- Enroll in school and attend daily
- Comply with DJJ Probation
- Continue to comply with counseling services.
- Continue writing in daily journal.

*Other requirements may be added based on the needs of the individual.

Phase Three:

Community Reentry Phase

The Continuing Care Phase begins once a juvenile has successfully completed Phase Two and will continue as long as the juvenile is under DJJ supervision. The following objectives are to be accomplished during this phase:

- The juvenile will be prepared to function successfully when Post Commitment
- Probation (PCP) is no longer in place.
- The Juvenile Reentry Coordinator will continue to monitor the juvenile's progress in the program.
- Ensure that the juvenile and/or family is connected to any ancillary services suitable to their needs.
- Ensure the juvenile's successful adjustment and reintegration into the community.

Participant Requirements (if applicable):*

- Attend monthly court appearances.
- Comply with random drug screens.
- Weekly case management sessions.
- Start writing in your daily journal.
- Continue attending school daily.
- Comply with DJJ Probation.
- Completion of counseling services.

*Other requirements may be added based on the needs of each individual participant.
