## NOTICE OF FINAL EVIDENTIARY HEARING FOR TENANT EVICTION BY ZOOM

- 1. This hearing shall be held using the ZOOM video call process and all parties and counsel will need to be familiar with Zoom and have access to a telephone, webcam, laptop, or cellular telephone to participate in this hearing. Please dress appropriately for this hearing, just as if you were appearing in person before the Court. A ZOOM invitation to participate in this hearing is attached.
- 2. <a href="MYORTANT!">MPORTANT!</a> All attorneys, parties, and witnesses at the trial shall have the capability to appear by video, not merely audio. It is the responsibility of each party to ensure that their witnesses have that capability. The Court will not hear testimony by any witness, including a party, who is not present by video, so that the Court can assure that the witness is properly sworn, as well as to allow the Court to adequately assess the witness's demeanor.
- **3.** Virtual hearings are **only recorded when required by Florida law**, and no party shall record the proceedings except the Court.
- **4.** To submit prospective evidence for this hearing:

- a) All prospective evidence must be printed out even if you have filed it into the Court case file.
- **b)** All prospective evidence shall be provided to the Court and opposing party or counsel **no later than five (5) days prior** to the hearing. See (e) for address.
- **c)** Each submission must be identified by CASE NUMBER and identify which party is submitting the proposed evidence (ex. Plaintiff or Defendant).
- **d)** Evidence on **cell phones** (such as emails, texts and photographs) cannot be submitted into the Court unless they are **printed out.**
- e) All prospective evidence must be mailed or hand-delivered to the following address: Carla R. Pepperman, County Judge, Lake County Courthouse, Suite 9, 550 West Main Street, Tavares, FL 32778; or may be hand-delivered by courier to: Mail Receiving Center, Records Storage Facility, 313 South Bloxam Avenue, Tavares, FL 32778.
- 5. Corporate litigants are reminded that they MUST APPEAR with counsel as required under Florida law. Szteinbaum v. Kaes Inversiones y Valores, 476 So. 2d 247, 248 (Fla. 3d DCA 1985) ("[i]t is well recognized that a corporation, unlike a natural person, cannot represent itself and cannot appear in a court of law without an attorney) (citing Nicholson Supply Co. v. First Federal Savings & Loan Association of Hardee County, 184 So. 2d 438 (Fla. 2d DCA 1966)). No exceptions shall be made as it would constitute the unlicensed practice of law.
